

Terms of Use

Effective Date. July 21st, 2022

Definitions. “Gradient Music” means Ticket to the Moon, Inc. a Delaware corporation with its address at 187 E. Warm Springs Rd., Suite B495, Las Vegas, Nevada 89119. “GRADIENT MUSIC Content” means content owned or licensed by GRADIENT MUSIC. “Gradient Music Parties” means Gradient Music together with its employees, managers, officers or agents. “Service” means the Gradient Music service, or any applications (including mobile applications) made available by Gradient Music. “Terms of Use” means these terms of use, as they may be amended from time to time by Gradient Music in its discretion pursuant to the terms hereof. “You” means you, the user of the Service. “Your Content” means any images, graphics, photos, audio and video clips, sounds, and other content or materials that you create on, upload to, or stylize using the Service.

Service Age Restriction. You must be at least 13 years old to use the Service.

Your Obligations.
